### **Aetna Foundation Regional Community Health Grants**

The Aetna Foundation, a philanthropic program of Hartford-based Aetna, is inviting proposals for its Regional Community Health Grants Program. The program provides funding focused on reducing disparities in health care among racial and ethnic populations in eligible geographic areas. In 2005, Aetna will devote up to \$2.6 million to regional initiatives to address this issue. Grant requests ranging from \$25,000 to \$50,000 that address diabetes initiatives targeting individuals and families with prevention and healthy behavior modification messages to help combat the growing incidence of type 2 diabetes in children and adults; and screening, education. Only programs serving eligible geographic areas are eligible to apply. Applicants must be nonprofit organizations with evidence of IRS 501(c)(3) designation or de facto tax-exempt status. Proposals are accepted only through the Aetna Foundation's online system. See the foundation's Web site for complete program guidelines, eligible geographic areas, regional deadlines, and application procedures.

## **Lego Children's Fund**

The Lego Children's Fund makes cash grants to qualified 501(c)(3) tax-exempt organizations with programs dedicated to a child's (birth to age 14) exploration of creativity with priority consideration for disadvantaged or at-risk youth. The fund's cash grants will generally range between \$500 and \$5,000 each. Educational organizations may also apply for support of specific, identifiable needs primarily in these areas: early childhood education and development; technology and communication projects that advance learning opportunities; and sport or athletic programs that concentrate on underserved youth. The fund also makes one \$100,000 grant per year to a single organization identified and selected by its own board of directors. ## **Opportunities for Youth/Youthbuild Program**

The Youthbuild program provides funding assistance for a wide range of multi-disciplinary activities and services to assist economically disadvantaged youth. The opportunities are designed to help disadvantaged young adults who have dropped out of high school to obtain the education and employment skills necessary to achieve economic self-efficiency and develop leadership skills and a commitment to community development in low-income communities. Another important objective of the Youthbuild program is to expand the supply of permanent affordable housing for homeless persons and members of low income and very low-income families. By giving disadvantaged young adults participating in the program meaningful on-site training experiences constructing or rehabilitating housing as a community service, they are helping to meet the housing needs of homeless and low income families in their community. Possible examples of tailor-
